## **Regular Board Meeting**

## **New Business**

**Consideration/Action:** Swearing in of new Trustees

**Consideration/Action:** Appointment of vacant mayor position

Adam Evans made a motion to appoint Pat Forhan as mayor. Dave Crawford 2<sup>nd</sup> – roll call on motion: with Dave Crawford - Aye, Adam Evans - Aye, Danny Beard - Aye, Allie Hunter – Aye and Pat Forhan – Abstain, motion carried.

Consideration/Action: Declaration of vacant trustee(s) position and appointment to fill

Pat advised that he would like to appoint Shannon Links for the vacant unexpired 2-year term and Brenda Kleinik to take over his position as Trustee. Adam made a motion to accept the appointments. Danny 2<sup>nd</sup> – roll call on motion, with all yes, motion approved. New members were then sworn in by Clerk Loni Hensler.

They are seeking permission to do so from the Village. They were advised to go ahead and get quotes and once they have them, a special meeting can be held to make the approval.

Molly Kious asked if the meetings could be live-streamed and spoke about her concerns of a member on the board having too much access to funds.
